# 1 Scope

---

This Bluetooth document contains the Test Suite Structure (TSS) and test cases to test the implementation of the Bluetooth Hearing Access Service with the objective to provide a high probability of air interface interoperability between the tested implementation and other manufacturers' Bluetooth devices.

## 3 Test Suite Structure (TSS)

### 3.1 Overview

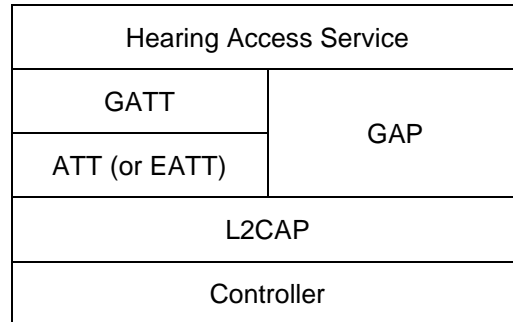


Figure 3.1: Hearing Access Service test model

The Hearing Access Service requires GAP, GATT, and L2CAP. This is illustrated in [Figure 3.1](#).

### 3.2 Test Strategy

The test objectives are to verify the functionality of the Hearing Access Service within a Bluetooth Host and enable interoperability between Bluetooth Hosts on different devices. The testing approach covers mandatory and optional requirements in the specification and matches these to the support of the IUT as described in the ICS. Any defined test herein is applicable to the IUT if the ICS logical expression defined in the Test Case Mapping Table (TCMT) evaluates to true.

The test equipment provides an implementation of the Radio Controller and the parts of the Host needed to perform the test cases defined in this Test Suite. A Lower Tester acts as the IUT's peer device and interacts with the IUT over-the-air interface. The configuration, including the IUT, needs to implement similar capabilities to communicate with the test equipment. For some test cases, it is necessary to stimulate the IUT from an Upper Tester. In practice, this could be implemented as a special test interface, a Man Machine Interface (MMI), or another interface supported by the IUT.

This Test Suite contains Valid Behavior (BV) tests complemented with Invalid Behavior (BI) tests where required. The test coverage mirrored in the Test Suite Structure is the result of a process that started with catalogued specification requirements that were logically grouped and assessed for testability enabling coverage in defined test purposes.

### 3.3 Test groups

The following test groups have been defined:

- ATT Configuration
- Generic GATT Integrated Tests
- Hearing Aid Preset Control Point Procedures
- Service Procedure – Error Handling
- Validation Tests

## 4 Test cases (TC)

### 4.1 Introduction

#### 4.1.1 Test case identification conventions

Test cases are assigned unique identifiers per the conventions in [2]. The convention used here is:

**<spec abbreviation>/<IUT role>/<class>/<feat>/<func>/<subfunc>/<cap>/<xx>-<nn>-<y>.**

Additionally, testing of this specification includes tests from the GATT Test Suite [5] referred to as Generic GATT Integrated Tests (GGIT); when used, the test cases in GGIT are referred to through a TCID string using the following convention:

**<spec abbreviation>/<IUT role>/<GGIT test group>/< GGIT class >/<xx>-<nn>-<y>.**

#### 4.1.2 Conformance

When conformance is claimed for a particular specification, all capabilities are to be supported in the specified manner. The mandated tests from this Test Suite depend on the capabilities to which conformance is claimed.

The Bluetooth Qualification Program may employ tests to verify implementation robustness. The level of implementation robustness that is verified varies from one specification to another and may be revised for cause based on interoperability issues found in the market.

Such tests may verify:

- That claimed capabilities may be used in any order and any number of repetitions not excluded by the specification
- That capabilities enabled by the implementations are sustained over durations expected by the use case
- That the implementation gracefully handles any quantity of data expected by the use case





- That in cases where more than one valid interpretation of the specification exists, the implementation complies with at least one interpretation and gracefully handles other interpretations
- That the implementation is immune to attempted security exploits

A single execution of each of the required tests is required to constitute a Pass verdict. However, it is noted that to provide a foundation for interoperability, it is necessary that a qualified implementation consistently and repeatedly pass any of the applicable tests.

In any case, where a member finds an issue with the test plan generated by the Bluetooth SIG qualification tool, with the test case as described in the Test Suite, or with the test system utilized, the member is required to notify the responsible party via an erratum request such that the issue may be addressed.

### 4.1.3 Pass/Fail verdict conventions

Each test case has an Expected Outcome section. The IUT is granted the Pass verdict when all the detailed pass criteria conditions within the Expected Outcome section are met.

The convention in this Test Suite is that, unless there is a specific set of fail conditions outlined in the test case, the IUT fails the test case as soon as one of the pass criteria conditions cannot be met. If this occurs, then the outcome of the test is a Fail verdict.

## 4.2 Setup preambles

The procedures defined in this section are used to achieve specific conditions on the IUT and the test equipment within the tests defined in this document. The preambles here are commonly used to establish initial conditions.

### 4.2.1 ATT Bearer on LE Transport

- Preamble Procedure
  1. Establish an LE transport connection between the IUT and the Lower Tester.
  2. Establish an L2CAP channel 0x0004 between the IUT and the Lower Tester over that LE transport.

### 4.2.2 EATT Bearer on LE Transport

- Preamble Procedure
  1. Establish an LE transport connection between the IUT and the Lower Tester.
  2. Establish an L2CAP channel 0x0005 for signaling and one L2CAP channel (for ATT bearers) with EATT PSM (as defined in Assigned Numbers) between the IUT and the Lower Tester over that LE transport.

### 4.2.3 Hearing Aid Preset Control Point

#### 4.2.3.1 Preset Control Point

- Preamble Purpose

This preamble procedure enables the IUT for use with the Hearing Aid Preset Control Point.

- Preamble Procedure
  1. Establish an ATT Bearer connection between the Lower Tester and the IUT as described in Section 4.2.1, if using ATT over an LE transport, or Section 4.2.2 if using EATT over an LE transport.
  2. The handle of the Hearing Aid Preset Control Point characteristic has been previously discovered by the Lower Tester during a test procedure in Section 4.3 or is known to the Lower Tester by other means.
  3. The handle of the Client Configuration descriptor of the Preset characteristic has been previously discovered by the Lower Tester during a test procedure in Section 4.3 or is known to the Lower Tester by other means.
  4. If the IUT requires bonding, then the Lower Tester performs a bonding procedure.
  5. Enable GATT indications and optionally notifications by performing the preamble in Section 4.2.4.

#### 4.2.4 GATT Notification and Indication

The procedures defined in this section are provided to set up notifications and indications for the EATT or Unenhanced ATT bearers.

##### 4.2.4.1 EATT Bearer, Notifications and Indications

- Preamble Purpose

This preamble procedure enables the IUT with an EATT Bearer to use indications, and optionally notifications, with the Hearing Aid Preset Control Point.
- Preamble Procedure
  1. The Lower Tester writes the value 0x0002 if indications are supported and notifications are not supported, or 0x0003 if both indications and notifications are supported, using the GATT Write Characteristic Descriptor sub-procedure to the IUT for the Preset Control Point CCCD.

##### 4.2.4.2 Unenhanced ATT Bearer

- Preamble Purpose

This preamble procedure enables the IUT with an Unenhanced ATT Bearer to use indications with the Hearing Aid Preset Control Point.
- Preamble Procedure
  1. The Lower Tester writes the value 0x0002 using the GATT Write Characteristic Descriptor sub-procedure to the IUT for the Preset Control Point CCCD.

### 4.3 Generic GATT Integrated Tests

Execute the Generic GATT Integrated Tests defined in Section 6.3, Server test procedures (SGGIT), in [5] using Table 4.2 below as input:

## 4.4 Server Configuration

Verify the Server Configuration.

### HAS/SR/CFG/BV-01-C [Verify the ATT Server MTU Value]

- Test Purpose

Verify that a HAS Server IUT supports an ATT\_MTU value of at least 49.
- Reference

[3] 1.4
- Initial Condition
  - Establish a Bearer connection between the Lower Tester and the IUT as described in Section 4.2.1 using ATT over an LE transport.
- Test Procedure
  1. The Lower Tester sends an ATT\_EXCHANGE\_MTU\_REQ to the IUT with Client Rx MTU set to 50.
  2. The IUT sends an ATT\_EXCHANGE\_MTU\_RSP to the Lower Tester with Server Rx MTU set  $\geq 49$ .
- Expected Outcome

Pass verdict

In Step 2, the IUT sets the Server Rx MTU  $\geq 49$ .

## 4.5 Hearing Aid Features

Verify that the Hearing Aid Feature bits in the Hearing Aid Features characteristic are set properly.

### 4.5.1 Hearing Aid Feature bits

- Test Purpose

Verify that a HAS Server IUT has the feature bits in the Hearing Aid Feature characteristic properly set.
- Reference

[3] 3.1
- Initial Condition
  - Establish a Bearer connection between the Lower Tester and the IUT as described in Section 4.2.1, if using ATT over an LE transport, or Section 4.2.2 if using EATT over an LE transport.
  - The IUT has the Hearing Aid Features characteristic set to reflect its capabilities.

- Test Case Configuration

- Test Procedure

1. The Lower Tester executes the GATT Read sub-procedure for the Hearing Aid Features characteristic.
2. The Lower Tester verifies that the bits in the Hearing Aid Features characteristic are set as specified in [Table 4.3](#).

- Expected Outcome

Pass verdict

In Step 1, the IUT returns the Hearing Access Features characteristic with the bit and value as specified in [Table 4.3](#).

## 4.6 Active Preset Index

Verify the Active Preset Index.

### HAS/SR/AI/BV-01-C [Active Preset Index Notifications]

- Test Purpose

Verify that a HAS Server IUT properly updates the Active Preset Index characteristic when the IUT autonomously changes the preset in use.

- Reference

[\[3\]](#) 3.2

- Initial Condition
  - Establish a Bearer connection between the Lower Tester and the IUT as described in Section 4.2.1, if using ATT over an LE transport, or Section 4.2.2 if using EATT over an LE transport.
  - The IUT enables notifications by writing the value 0x0001 using the GATT Write Characteristic Descriptor sub-procedure for the Active Preset Index characteristic.
  - The Active Preset Index Characteristic on the IUT is Index 0.
  - The list of Preset Record indexes that are Available is defined by the TSPX\_available\_preset\_index IXIT value.
- Test Procedure
 

Repeat Steps 1–3 for each Preset\_Index in TSPX\_available\_preset\_index.

  1. The Upper Tester instructs the IUT to use the preset with Preset\_Index.
  2. The IUT sends a GATT Characteristic Value Notification for the Active Preset Index characteristic with the Index set to Preset\_Index.
  3. The Lower Tester executes the GATT Read sub-procedure for the Active Preset Index characteristic.
- Expected Outcome
 

Pass verdict

In Step 2, the IUT sends an Active Preset Index notification for the Preset\_Index.

In Step 2, the IUT returns the Active Preset Index set to Preset\_Index.

## 4.7 Control Point Procedures

Verify Hearing Aid Preset Control Point procedures.

### HAS/SR/CP/BV-01-C [Read Presets Request]

- Test Purpose
 

Verify that a HAS Server IUT correctly responds to the Read Presets Request procedure for a single record.
- Reference
 

[3] 3.2.2.1
- Initial Condition
  - Establish a Bearer connection between the Lower Tester and the IUT as described in Section 4.2.1, if using ATT over an LE transport, or Section 4.2.2 if using EATT over an LE transport.
  - Enable the Hearing Aid Preset Control Point in the IUT by performing the preamble described in Section 4.2.3.
  - The largest of preset index is defined by the TSPX\_largest\_preset\_index IXIT value.
  - The IUT Preset Records with Index 1 and TSPX\_largest\_preset\_index have Name set to a UTF-8 encoded string.
  - The number of total presets is defined by the TSPX\_num\_presets IXIT value.



- Test Procedure

Repeat Steps 1–3 for each round in [Table 4.4](#).

1. The Lower Tester executes the GATT Write sub-procedure for the Hearing Aid Preset Control Point characteristic with the Read Presets Request Operation with StartIndex and NumPresets set as specified in [Table 4.4](#).
2. The Lower Tester receives a Write Response indicating that the IUT has accepted the Opcode.
3. The IUT sends a GATT Characteristic Value Notification or Indication for the Hearing Aid Preset Control Point characteristic to the Lower Tester with Opcode set to “Read Preset Response” with isLast set to 0x01, the Preset record with Index set to the value in Step 1, and Properties and Name set to the values for the Preset record.
4. Repeat Step 2 for the Records Returned specified in [Table 4.4](#).

- Expected Outcome

Pass verdict

In each round, the IUT sends a notification or indication to the Lower Tester in Step 2 with the Preset record with a UTF-8 encoded string for the Index in Step 1.

The last Preset record notification or indication in Step 2 has isLast set to 0x01.

## HAS/SR/CP/BV-02-C [Preset Changed]

- Test Purpose

Verify that a HAS Server IUT sends a Preset Changed to the Lower Tester with the changed Preset record.

- Reference

- Initial Condition

- 1A.2 The IUT sends an ATT Error Response to the Lower Tester with the Out of Range (0xFF) error code.

1A.3 The Lower Tester executes the GATT Write sub-procedure for the Hearing Aid Preset Control Point characteristic with the Read Presets Request Operation with StartIndex set to 0xFF and NumPresets set to 1.

1A.4 The IUT sends an ATT Error Response to the Lower Tester with the Out of Range (0xFF) error code.

Alternative 1B (Index = 0):

1B.1 The Lower Tester executes the GATT Write sub-procedure for the Hearing Aid Preset Control Point characteristic with the Read Presets Request Operation with StartIndex set to 1 and NumPresets set to 1.

1B.2 The IUT sends an ATT Error Response to the Lower Tester with the Out of Range (0xFF) error code.

- Expected Outcome

Pass verdict

In Steps 1A.2, 1A.4, and 1B.2, the IUT returns an Out of Range error code.

## 5 Test case mapping

The Test Case Mapping Table (TCMT) maps test cases to specific requirements in the ICS. The IUT is tested in all roles for which support is declared in the ICS document.

The columns for the TCMT are defined as follows:

**Item:** Contains a logical expression based on specific entries from the associated ICS document. Contains a logical expression (using the operators AND, OR, NOT as needed) based on specific entries from the applicable ICS document(s). The entries are in the form of y/x references, where y corresponds to the table number and x corresponds to the feature number as defined in the ICS document for Hearing Access Service [4].

If a test case is mandatory within the respective layer, then the y/x reference is omitted.

**Feature:** A brief, informal description of the feature being tested.

**Test Case(s):** The applicable test case identifiers are required for Bluetooth Qualification if the corresponding y/x references defined in the Item column are supported. Further details about the function of the TCMT are elaborated in [2].

For the purpose and structure of the ICS/IXIT, refer to [2].
